The grant of this permission shall, however, not entitle the school to any grant-in-aid from this Department or the Govt. of H.P.

This N.O.C. is issued subject to the following conditions.

1. No pupil shall be refused admission on account of his caste creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste creed or religion.
2. No pupil shall be compelled to attend a class in which a religious instruction is given or take part in any religious exercises.
3. The school with its account books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Department, Executive Officers of the Govt. authorised to inspect schools and Health Officer deputed by the Health Department to examine the health of the students or sanitary condition of the building and premises.
4. The schools shall have to furnish all information and returns as called for by the Department from time to time.
5. The school shall comply with the rules of the Department and directions as given by the department so far as they are applicable to private schools in the interest of maintaining education standard. The Director of Education shall have the authority to send any of his officers for inspection for proper maintenance of educational standards, holiday as per State Govt. etc.
6. The school staff and students shall not take part in any agitation directed against the authority of Govt. or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt. or of enmity and hatred between different communities.
7. The School shall charge the rates of tuition fee and subscription to boys funds in accordance with the scales prescribed and approved by the Education Department of H.P./CBSE/ISSB and schools shall have to submit a classwise list of tuition fee and funds to this Directorate.

- ✓ 8. The schools shall maintain the discipline properly.
- ✓ 9. The school shall take steps to promote the use of Hindi. The extent of reservation for SC&ST students at the time of admission may be adhered to.
- ✓ 10. The school shall have to work within the framework of National priorities.
- ✓ 11. In the matter of appointments of teaching/non-teaching staff preference will be given to the Himachalis.

The breach of any of the conditions specified above shall render the school defaulter and the Director of Education after conducting any enquiry through any of the officers so designated by him, shall have the power to cancel the N.O.C.
